

BusinessHub Referral Program

Thank you for your referral of a potential new client to BusinessHub Pty Ltd ACN 106 092 068 ('BusinessHub', 'we', 'us', 'our'). By sending us a referral using the [referral form](#), you agree to be bound by the following BusinessHub Referral Program terms and conditions.

1. The BusinessHub Referral Program is not valid in conjunction with any other offer.
2. We will provide you with a \$500 eGift Card for each Qualified Lead. A Qualified Lead is a qualifying customer based on product and service fit, eligibility, propensity to buy, among other criteria. BusinessHub will determine this qualification at its sole discretion.
3. Eligible product and services are: implementation, support and/or consulting services to be delivered by BusinessHub under a Success Plan or Onboarding Services Agreement relating to MYOB Advanced or Wiise Subscription Service. This offer does not apply to referrals for any other software or services.
4. To refer a customer, you must complete the [referral form](#). An attempt to make a referral in any other way will not be valid.
5. The referral incentive is only applicable when the referred customer has not previously been a BusinessHub customer or is not already identified as a potential BusinessHub customer in our CRM database.
6. Referrals are not valid where the referee and the referred customer are one and the same person. If more than one referee refers the same customer, then the first valid referral received by BusinessHub will be eligible for referral incentive.
7. Referrals will be valid for six months from the date a referral is received by BusinessHub. If the referred customer has not in this time signed a BusinessHub Onboarding Services Agreement or Success Plan, then the initial referral will be considered void.

Incentive e-Gift Cards will be emailed to your email address stated in the [referral form](#) upon successful referrals within 30 days of the end of the month during which BusinessHub received the first payment due from your referred customer under their Onboarding Services Agreement or Success Plan (as applicable) with BusinessHub.
9. This BusinessHub Referral Program may be terminated or changed at BusinessHub's discretion at any time and without notice.
10. Respecting your privacy as well as the privacy of referred customers is a priority for us. By submitting a referral you are accepting these terms and conditions and you represent that you have the authority to disclose the personal details of the referred customer. To the maximum extent permitted by law, our maximum aggregate liability in connection with these terms and conditions (whether in contract or tort (including without limitation negligence), in equity, under statute or on any other basis) for all claims arising under these terms and conditions is limited to the greater of 100% of the amounts paid by BusinessHub to you under the BusinessHub Referral Program in the 6 months prior to the claim arising, or \$1,000.
